### MINISTRY OF ECONOMY, INFRASTRUCTURE, SHIPPING AND TOURISM

By decision no. 2901.01 / 71/2015 / 27-5-2015 of the Minister of Economy, Infrastructure, Shipping and Tourism and the Deputy Minister of Economy, Infrastructure, Shipping and Tourism, issued in accordance with Articles 55, 56 and 57 of PD 63/2005 and Articles 23 and 24 of Law. 4320/2015, amending decision no. 2901.01 / 63/2015 / 13-5-2015 (YODD352) similar as to the starting date of the secondment, which shall be the 30-3 -2015, with which Theodoros Thalassinos of Michael with ID No.: 639 693, a permanent employee of the Economics Management department of the Ministry of Economy, Infrastructure, Shipping and Tourism, is transferred to the vacant position of special consultant Category PE with B grade, at the Political Bureau of the Deputy Minister of Economy, Infrastructure, Shipping and Tourism, Theodoros Dritsas.

The above mentioned person shall be remunerated by the Department to which he shall be seconded.

Creation, establishment and appointment of members of the Working Group to the General Accounting Office to process the provisions of public accounting.

### THE FINANCE MINISTER:

Having in mind:

1. The provisions:

a) of Article 34 of Law. 1914/1990 "Modernization and development of the public sector and capital market, tax arrangements and other provisions" (A 178), as clarified by paragraph 1 of Article 13 of Law. 2346/1995 (A 220)

b) of Presidential Decree 111/2014 "the Ministry of Finance Organization" (A 178), as amended and in force,

c) of Article 13 of Law no. 2690/1999 "Ratification of the Administrative Procedure Code and other provisions" (A 45)

d) of Article 90 of the "Code of Legislation on Government and Governmental Bodies" as ratified by the first article of PD 63/2005 (A 98).

2. The No. 2/83431/0004 / 24.10.2014 decision of the Deputy Minister of Finance on "Creation, establishment and appointment of members of the Working Group on elaboration of the provisions of public accounting" (DOSS 678), as amended by the No. 2 / 88488/0004 / 12.12.2014 similar (DOSS 807).

3. No. 596 / 04.06.2015 document of the Director of the Office of the Deputy Minister of Finance.

4. The No. 2/23825 / DPDA / 04.16.2015 document of the Finance Division of the Ministry of Finance, which confirms the commitment of the necessary credit (SAA: 6CHCHTHI-MLR) and No 2/30 883 / DPDA / 6.5. 2015 2/34114 / DPDA / 05.20.2015 complementary to that (SAA: 63PSYI-CXA and 6741-F2CH respectively).

5. The need for reopening of the working group for the processing of public accounting rules in order to complete the work of decision NO. 2/83431/0004 / 24.10.2014, as amended.

6. The fact that the provisions of this decision will cause expenditure of 8,250 Euros, which will burden the expenses budget OEM 0515 and institution 23-140 of the Finance Ministry, for the year 2015, we decide:

A. The creation and establishment of the General Accounting Office Working Group on elaboration of the provisions of public accounting and the appointment of the following as members:

The secretariat will be based on a rotation of members of the working group appointed by the Coordinator.

The Working Group works in plenary sessions and in sections. The number of departments and the members that make up each of them, are determined according to the theme, by decision of the Coordinator. The sections are chaired by Working Group members appointed by the Coordinator. At plenary sessions general issues are discussed, main guidelines to departments are given and final decisions related to its work are taken. The sections examine particular issues and formulate relevant recommendations to the plenary session of the Group.

In addition to the above members, the Coordinator may invite for participation in meetings representatives of other departments and institutions, if necessary.

B. The work of the Working Group is the processing of the provisions of Public Accounting in order to cover the various categories of legal entities of the Public Sector, the harmonization of public accounting provisions still contained in various other legislation, the formulation of suggestions for reforming the enforcement procedures of the Budget, and the overall review of the provisions of Law 4270/2014 (A'143).

C. The working group will meet in or/and out of normal working hours of the public services time schedule at the central building of General Accounting Office of the State and will complete its mission by 30/7/2015.
